Ingilab AHMADOV is the Director of Eurasia Extractive Industries Knowledge Hub and Dean of the School of Economics and Management at Khazar University in 2010. He started his career as an instructor at the Azerbaijan State Oil Academy and as a scientific employee at the Center for Strategic and International Studies. Subsequently, he was appointed as Advisor to the Minister at the Ministry of Economy of the Republic of Azerbaijan. Since 1995, he acts as Director General of the "Trend" analytical information agency and between 2004 and 2010 he was a Director of the Public Finance Monitoring Center - an NGO located in Baku. Prof. Ahmadov has research collaborations and is a visiting professor at the following leading universities: Kiel Institute for the World Economy, Oxford

University, and Reading University. His research interests include oil & gas economy, the economic impact of oil revenues, Caspian energy resources and oil contracts. Prof. Ahmadov has written more than 30 research papers and books. Mr. Ahmadov joined School of Economics and Management, Khazar University in 2008. His main lecturing subjects are Energy Management, Caspian Energy. Prof. Ingilab Ahmadov is a former member of the International Board of the Extractive Industries Transparency Initiative.

Prof. Ahmadov holds a Doctorate in Economic Science from the Saint-Petersburg State University of Economics and Finance (Russia). In 2008 as a Chevening Fellow, Mr. Ahmadov studied "Economics of Energy" course at Reading University (UK).

Péter BALÁZS is director of the Center for EU Enlargement Studies which he established in 2005. Research activities of Prof. Balázs are centered on the foreign policy of the EU and problems of the late modernization and European integration of the Eastern part of the continent. He is also analyzing the questions of European governance including the future of European institutions. He graduated in Budapest at the Faculty of Economics of the "Karl Marx" University (later: Budapest School of Economics, today Corvinus University). He got his PhD degree and habilitated at the same University. He is a ScD of the Hungarian Academy of Sciences. In parallel with his government and diplomatic career he has been teaching and doing research. He was nominated Professor



of the Corvinus University in 2000 and joined the CEU as a full time Professor in 2005. He is

regularly teaching at various home and foreign universities, lecturing in English, French, German and Hungarian.

After the systemic change in 1990 Prof. Balázs joined the Government of Hungary several times. He was a State Secretary for Industry and Trade (1992-1993) and a State Secretary for European Integration (2002-2003). He was Ambassador of Hungary in Denmark (1994-1996), Germany (1997-2000) and to the EU in Brussels (2003-2004). He was also the Government Representative of Hungary in the European Convention drafting the Constitutional Treaty which became later, after several modifications, the Lisbon Treaty. In 2004 he was nominated the first Hungarian Member of the European Commission responsible for regional policy. In 2009-2010 he was Foreign Minister of Hungary.



Vito BOBEK currently works as a professor of international management at the University of applied sciences FH Joanneum (Graz, Austria) and at the University of Maribor (Slovenia). He is also a manager and owner of Palemid - Consulting, Research, Education LLC. Other positions: Member of supervisory board at KBM Infond (Investment company, Maribor, Slovenia), Regional editor for Central and Eastern Europe at "European Journal of International Management", Member of editorial board at "International Journal of Trade and Global Markets", Member of editorial board at "Imago Europae" (Florence, Italy), Member of "Team Europe Slovenia". His research interests are related to International Business, Strategic Integration, Management, Regional Economic Cross-Cultural

Management and Management of Cities and Regions.

Haris BOKO is the Chief Adviser with Hrvoje Pozar Energy Institute, the leading regional energy consultancy, responsible for international business advisory services and management of key projects. He holds B.Sc., M.Sc. and Ph.D. degrees in Electrical Engineering and has managerial schooling from Harvard Business School, Harvard's JF Kennedy School of Government and McGill University. He was Senior Fellow with the London School of Economics and Political Science engaged with development of emerging markets. In his previous capacity as the State Secretary and Director of the Croatian National Developmental Agency, Haris was in charge of all national developmental projects, in both private and public sector. In his career, he has been project director on numerous



international infrastructural tenders under private, World Bank and European Commission procurement. Previous professional engagements were in Tokyo, London, Vienna, Montreal and Boston while advising The World Bank and United Nations as well as leading private consultancies. Haris has been the Dean and is the professor of strategic management with the

leading Business School that is holding worldwide quality assurance accreditation by Association of MBA Schools.



András DEÁK is an Associate Fellow on Energy Security at the Hungarian Institute of International Affairs.. He received his Diploma (MA) and his Doctorate (Ph.D.) in International Relations, in 1997 and 2003, respectively, both from the University of Economic Sciences, Hungary. His special field of interest is the Political economy of Post Soviet energy with a particular focus to Russia and Ukraine. His activities include foreign and energy policy analysis, political and corporate consultancy on Hungarian or CEE – Russian energy relations, teaching (1-2 courses at the Corvinus University)

and also some civil activities in energy conservation.

Péter HÓNIG was Minister of Telecommunication, Transportation and Energy between 2009 and 2010. Currently, he is personal advisor about career development and company culture at Hotan Entreprise, a position he has been holding for almost ten twenty years. During his carrer he worked in various leadership positions both in the public and private sector: he has been deputy CEO of Budapest Power Plant Zrt. (2007-2009), vice president of the supervisory board at GE Zenon (2006-2009), president and CEO of Transelektro in 2006, president of the board of MALEV Hungarian Airlines (2005-2007), president and CEO of Dunaferr Rt. Danube Iron Works LTD (2002-2005), vice president of ABB Hungary (2000-2002) and deputy state secretary responsible for industry, energy, domestic trade and technical regulation (1998-2000).

Nikolay KAVESHNIKOV is Head of Department of European Integration Studies at the Moscow State Institute of International Relations (MGIMO-University). He also holds an office of leading research fellow at the Institute of Europe of the Russian Academy of Science (Moscow). He obtained his Ph.D. in Political Science in 2006 in the Institute of Europe. Since 2012 he holds a Jean Monnet Chair.

His research interests include EU-Russia relations, EU energy policy, institutional development of the European Union and EU external relations. Nowadays he teaches courses on Energy Policy of the EU, on EU in the System of International Relations and overview course on European Integration.

Dr. Kaveshnikov is author of more than 90 publications including articles in European Security, Journal of Communist Studies and

Transition Politics, Mejdunarodnaia jizn, Mejdunarodnye protsessy, Sovremennaya Evropa, European University Institute Working Papers etc. He published a book Transformation of the Institutional Structure of the European Union (Navona, 2010). He regularly provides expertise for the Ministry of Foreign Affairs of the Russian Federation. His participated in research and consulting projects for, inter alia, the Eurasian Development Bank, the Russian Academy of Science, the European Commission.




Andrej NOSKO is senior program officer at Think Tank Fund, overseeing the portfolio of project grants in EU countries, and support for integration of new technologies and communications tools within the think tank community. His academic interest is in the political economy of security, and energy security policies of countries in transition, focusing on Central Europe. He has worked with and led an international group of researchers advocating for closer transnational cooperation in improving energy security in Europe. Previously Nosko worked at the European Commission's Directorate General for Justice Freedom and Security (now DG Home Affairs) on issues of improving the exchange of information between law enforcement bodies.

Nosko received his undergraduate degree from Charles University in Prague, graduate degree in International Relations and European Studies at Central European University in Budapest, also spent time studying in Sweden, Poland and USA, he is currently finishing his PhD research at Political Science Department of Central European University. John SHATTUCK, is president and rector of the Central European University. He came to CEU after a distinguished career spanning more than three decades in higher education, international diplomacy, foreign policy and human rights. Before coming to CEU, he was CEO of the John F. Kennedy Library Foundation, a national public affairs center in Boston, and Senior Fellow at Tufts University, where he taught human rights and international relations. President Shattuck served as Assistant Secretary of State for Democracy, Human Rights and Labor under President Clinton, playing a major role in the establishment by the United Nations of the International Criminal Tribunals for Rwanda and the former Yugoslavia; assisting an international coalition under UN authority to restore a democratically-elected government to Haiti; and negotiating

the Dayton Peace Agreement and other efforts to end the war in Bosnia. Subsequently he served as US Ambassador to the Czech Republic, working with the Czech government to assist in overhauling the country's legal system, and with Czech educators to support innovative civic education programs in the country's schools and universities. In recognition of his human rights leadership, he has received the International Human Rights Award from the United Nations Association of Boston; the Ambassador's Award from the American Bar Association Central and East European Law Initiative; and the Tufts University Jean Mayer Global Citizenship Award. A graduate of Yale Law School, where he received a JD degree, Shattuck was awarded an MA from Clare College, Cambridge University, with First Class Honors in international law, and a BA from Yale College, magna cum laude and Phi Beta Kappa.

Konstantin SIMONOV is founder and director general of the National Energy Security Fund in Russia. Majored in political sciences and economics at the Moscow State University. PhD in Political Science. In 1999, upheld thesis «Political Analysis within the System of Applied Political Science» at the Moscow State University. Has a master's degree in political sciences of the Manchester University. Associate professor for the theoretical political sciences department at the Moscow State University. The head of the department of economic political science of faculty of sociology and political science of Financial University at the Government of the Russian Federation. Has been engaged in political science and economic analysis for 15 years. In 2003 became chief of the Center for Current Politics. In summer 2006 founded and became head of The National Energy Security Fund.



Specializes in nonpublic politics, executive power of Russia, political risks, economic interests of political elites. His mission is to study economic aspects of the political processes and political aspects of the economic processes. Author of many books and text-books. Has published over a thousand articles in Russian and foreign mass-media (Nezavisimaya Gazeta, Izvestiya, Vremya

Novostei, Gazeta, Neft Rossii, Neftegazovaya vertical, Mirovaya Energetika, Soobscheniye, Gazeta Wyborcza, Rzeczpospolita and other) on home and foreign policy of Russia, energy and economics, outlook on the transformation of the Russian state. Since 2005 contributes to Vedomosti as regular columnist. Actively participates in international forums and conferences on the development of the Russian oil & gas industry and the outlook on the Russian state.



Elnur SOLTANOV is an assistant professor at Azerbaijan Diplomatic Academy and the Chair of the Caspian Center for Energy and Environment. He earned Master's degree in International Relations from Middle East Technical University (METU) in Turkey (2003), and PhD in Political Science from Texas Tech University (2009), USA. Between 2000 and 2003, Dr. Soltanov worked as a researcher at the Center for Eurasian Strategic Studies (ASAM) think-tank in Ankara, Turkey, where he also served as the editor of Avrasya Haber, a joint project with Turkish Cooperation and Development Agency (TCDA). Prior to joining ADA, Dr. Soltanov served as Assistant Professor of Political Science at the Truman State University, Missouri. 
