Péter BALÁZS is the director of the Center for EU Enlargement Studies which he established in 2005. His research activities include foreign policy of the EU, problems of the late modernization and European integration of the Eastern part of the continent and questions of European governance including the future of European institutions. He graduated in Budapest at the Faculty of Economics of the “Karl Marx” University (today Corvinus University). He got his PhD and habilitated at the same University. He is a ScD of the Hungarian Academy of Sciences. He was nominated Professor of the Corvinus University in 2000 and joined the Central European University as a full time Professor in 2005. He was State Secretary for Industry and Trade (1992-1993) and State Secretary for European Integration (2002- 2003). He was Ambassador of Hungary in Denmark (1994-1996), Germany (1997-2000) and to the EU in Brussels (2003-2004). He was also the Government Representative of Hungary in the European Convention drafting the Constitutional Treaty, which became later, after several modifications, the Lisbon Treaty. In 2004, he was the first Hungarian Member of the European Commission

Vladimír BARTOVIC is the director of EUROPEUM Institute for European Policy. He graduated in international trade and international politics at the University of Economics, Faculty of International Relations (Prague). He also studied at Universidad de Granada, Faculty of Political Science and Sociology.

In 2011-2012, he served as director of Strategic Planning and Analysis at the Department of the Ministry of Foreign Affairs of the Slovak Republic. He also worked as editor in *Integrace* magazine. He has been lecturing on topical EU issues at the Institute of Public Administration and the Czech National Bank. He co-operated with OSCE election missions in the Czech Republic, Slovakia and Kosovo. His main areas of expertise are: EU institutional issues, EU enlargement with the focus on Western Balkans, Slovak foreign and domestic policy and economic issues.





Levente BENKŐ is Undersecretary of State for security policy at the Ministry of Foreign Affairs and Trade of Hungary since 2014. Between 2010 and 2014 he served as the Head of the Department of Common Foreign and Security Policy of the Ministry of Foreign Affairs. Before joining the Ministry, he was the secretary of the Hungarian EPP delegation at the European Parliament (2008-2010), was foreign policy advisor at the Hungarian Parliament (2003-2008) and at the Prime Minister's Office (1999-2003). He graduated from the Faculty of Humanities of the Eötvös Loránd University in 2000 after studying history, English and political science.

Susi DENNISON is a senior policy fellow at the European Council on Foreign Relations (ECFR) where she works on a range of projects, including the annual Scorecard and the European Union's Global Strategy. Within the Middle East & North Africa Program, she focuses on EU relations with North Africa and takes a particular interest in human rights, justice, and democracy questions. Before joining ECFR in 2010, Susi worked for Amnesty International, carrying out advocacy on human rights protection and promotion in the EU's relationship with Africa, Asia, and the Americas. She was also the civil society representative in the Human Rights and Good Governance partnership of the EU Africa strategy from 2008 to 2010. Susi began her career in HM Treasury in the United Kingdom. There she held a range of positions, beginning in the EU Co-ordination and Strategy team of the then directorate for Macroeconomic Policy and International Finance working on the co-ordination of ECOFIN positions and contributing to the Social Europe Working Group of the Convention on the Future of Europe.



Edit INOTAI is an independent journalist and foreign policy analyst of the Hungarian business weekly Figyelő (Observer) and senior fellow at the Centre for Euro-Atlantic Integration in Budapest. Before joining CEID, she worked as the Foreign Editor of Népszabadság (2010-2014) after serving as correspondent in Berlin (2003-2007) and as a journalist at the Foreign Desk of Népszabadság (1997-2003) covering a wide range of topics. Her main focus areas were European affairs, Spain, Latin-America. She worked as a special envoy to Madrid, Buenos Aires and Santiago de Chile.
