Péter BALÁZS is director of the Center for EU Enlargement Studies which he established in 2005. Research activities of Prof. Balázs are centered on the foreign policy of the EU and problems of the late modernization and European integration of the Eastern part of the continent. He also analyzes the questions of European governance including the future of European institutions. Péter Balázs graduated in Budapest at the Faculty of Economics of the "Karl Marx" University (later: Budapest School of Economics, today Corvinus University). He got his PhD degree and habilitated at the same University. He is a ScD of the Hungarian Academy of Sciences. In parallel with his government and diplomatic career, he has been teaching and doing

research. He was nominated Professor of the Corvinus University in 2000 and joined the Central European University as a full time Professor in 2005. He is regularly teaching at various Hungarian and foreign universities, lecturing in English, French, German and Hungarian. After the systemic change in 1990, Prof. Balázs joined the Government of Hungary several times. He was State Secretary for Industry and Trade (1992-1993) and State Secretary for European Integration (2002-2003). He was Ambassador of Hungary in Denmark (1994-1996), Germany (1997-2000) and to the EU in Brussels (2003-2004). He was also the Government Representative of Hungary in the European Convention drafting the Constitutional Treaty, which became later, after several modifications, the Lisbon Treaty. In 2004, he was nominated the first Hungarian Member of the European Commission responsible for regional policy. In 2009-2010, he was Foreign Minister of Hungary.



Vasily ASTROV is Economist at the Vienna Institute of International Economic Studies (wiiw) and country expert on Ukraine, Russia and other CIS countries. His research focuses on macroeconomic analysis, financial markets and energy issues. He is also co-editor of the wiiw Monthly Report. In his recent research, he has analysed the economic effects of the global crisis and European energy security issues. He assembled comprehensive academic and international experience in the United Kingdom (University of Warwick), Germany (Westfälische Wilhelms Universität), Norway (University of Oslo) and Russia (St. Petersburg State University) and graduated in economics (M.Sc., Dipl.-Vw) and geography (B.A.).



Andrei V. BELYI (Andrey Belyy) is an Associate Professor at the University of Eastern Finland, a project researcher at the Centre for Climate Change, Energy and Environmental Law. Prior to 2015, he co-directed two Jean Monnet modules on energy and environment at the University of Tartu, Estonia. He also used to work at the Higher School of Economics in Moscow (Russia), where he co-directed Energy Policy Master Programmes from 2007 to 2012. In addition, he has been a Honorary Lecturer at the Centre for Energy, Petroleum, Mineral Law and Policy (Dundee, UK), provided short term lectures and workshops at the Global Energy Programme of the Warwick Business School (UK), at the Centre for Energy and Resources at the University College London in Adelaide, Australia, as well as at the

University of Aberdeen. In addition to that, Andrei V Belyi is a Member of Brussels Energy Club and is part of the Editorial board of the Journal for World Energy Law and Business (Oxford University Press). With 16 years of consultancy services, he provides advice for the EU institutions, Russian governmental agencies, companies and private firms. Andrei V. Belyi has participated in various research projects related to hydrocarbon markets and policies including the EU-funded Framework Programme 7 (Policies in Natural Resources, Polinares, www.polinares.eu) and a study for the Academy of Finland on behalf of the UEF.



Andrey CHERNYAVSKIY is Senior Research Fellow at the Institute "Development Center", National Research University Higher School of Economics in Moscow. He graduated from Moscow State University, Economic Faculty (1970-1975), PhD (1982). His profile of activity includes among others monitoring of problems in the public finance sphere at the federal and regional budget levels, analysis of the income and expenditures of federal and regional budgets, examination and preparation of opinions on draft laws on the federal budget, forecasting of parameters of the federal budget and the budgetary system for the medium and long term, analysis of the dynamics and structure of public and corporate debt. He has over 80 articles published in Russian and foreign journals.

András DEÁK is Head of Research Group "Economics of Globalization" at the Institute of World Economics, HAS, Budapest. He received his Diploma (MA) and his Doctorate (Ph.D.) in International Relations, in 1997 and 2003, respectively, both from the University of Economic Sciences, Hungary. His research fields cover economic processes in the Post-Soviet space, integration into the world economy and energy policy in particular. His activities include foreign and energy policy analysis, political and corporate consultancy on Hungarian and some civil activities in energy conservation.





Andrey MAKARYCHEV is Guest professor at the Institute of Government and Politics, University of Tartu. Before he came to Tartu he was Alexander von Humboldt Foundation fellow at Institute for East European Studies, Free University of Berlin, as well as Professor of International Relations at the Linguistic University (Nizhny Novgorod, Russia). His research interests include Russian foreign policy discourses, international security and regionalism in EU – Russia common neighborhood. He has worked for the Center for Security Studies & Conflict Research, ETH Zurich (2000-2001) and the Danish Institute for International Studies (DIIS), Copenhagen (2003-2004). He was visiting

fellow at several European and US Research Institutes, among them the Copenhagen Peace Research Institute; Kennan Institute for Advanced Russian Studies (Washington, D.C.); George Mason University, Fairfax, and the JFK Institute for North American Studies, Free University of Berlin. His projects were supported a.o. by Central European University, Budapest; IREX; McArthur Foundation; OSI; NATO Democratic Institutions Fellowship Program. Andrey also regularly comments on current events in the EU-Russia blog.

Yulia NIKITINA is Associate Professor of World Politics and Research Fellow at the Center for Post-Soviet Studies at the Moscow State University of International Relations (MGIMO). She is a specialist of security politics in Eurasia with a focus on regional organizations. She is the author of the book The CSTO and SCO: Models of Security Regionalism (Navona, 2009, in Russian) and of the handbook Introduction to World Politics and International Relations (Aspect-Press, 2009, in Russian). She has written several articles on the CSTO and SCO and co-authored the INSOR report CSTO: responsible security (2011).





Nikolay PETROV was the chair of the Carnegie Moscow Center's Society and Regions Programme. Until 2006, he also worked at the Institute of Geography at the Russian Academy of Sciences, where he started to work in 1982. He served as chief organizer of the Analysis and Forecast Division in the Supreme Soviet (1991–1992), adviser and analyst for the Russian Presidential Administration (1994–1995), and a scholar at the Kennan Institute for Advanced Russian Studies (1993–1994) and the International Foundation for Electoral Systems (1994). From

1996 to 2000, Petrov worked at the Carnegie Moscow Center as a senior consultant and scholar-in-residence. Petrov earned his Ph.D. from Moscow State University.

Anatoly RESHETNIKOV is a PhD Candidate and an Instructor of Research Design at the Department of International Relations, Central European University. He also teaches a course on Unorthodox Approaches to Russia's Politics and International Relations at Eötvös Loránd University, Budapest. In his dissertation, Anatoly is reconstructing the evolution of Russia's age-old idea of being a great power. His broader research interests include identity politics, history of ideas, linguistic approaches to social analysis,



contemporary Russian politics, and the concept of responsibility in international relations. In 2015, Anatoly worked as an affiliate researcher at the School of Slavonic and East European Studies, University of London. From January 2017, he will temporarily relocate to Lund University, where he will continue working on his research project. His publications include "Great Projects' Politics in Russia" (Demokratizatsiya, 2011) and "Frozen Transition: Russia and Great Power Crisis Management" (New Perspectives, 2016).
