## Bosnia and Herzegovina: Ethnicity, Politics, and Census -Or Why We Still Don't Know What *Us* Means-



**Péter BALÁZS** is a director of the Center for European Neighborhood Studies (CENS) which he established in 2005. Research activities of Prof. Balázs are centered on the foreign policy of the EU and problems of the late modernization and European integration of the Eastern part of the continent. He also analyzes the questions of European governance including the future of European institutions. Péter Balázs graduated in Budapest at the Faculty of Economics of the "Karl Marx" University (later: Budapest School of Economics, today Corvinus University). He got his PhD degree and habilitated at the same University. He is a ScD of the Hungarian Academy of Sciences. In parallel with his government and diplomatic career, he has been teaching and doing research. He was

nominated Professor of the Corvinus University in 2000 and joined the Central European University as a full time Professor in 2005. He is regularly teaching at various Hungarian and foreign universities, lecturing in English, French, German and Hungarian. After the systemic change in 1990, Prof. Balázs joined the Government of Hungary several times. He was State Secretary for Industry and Trade (1992-1993) and State Secretary for European Integration (2002-2003). He was Ambassador of Hungary in Denmark (1994-1996), Germany (1997-2000) and to the EU in Brussels (2003-2004). He was also the Government Representative of Hungary in the European Convention drafting the Constitutional Treaty, which became later, after several modifications, the Lisbon Treaty. In 2004, he was nominated the first Hungarian Member of the European Commission responsible for regional policy. In 2009-2010, he was Foreign Minister of Hungary.

Borislav BULJIĆ is a graduate of the Master's program in Nationalism Studies and currently works at Central European University. He previously worked in the field of international cooperation in the cultural sector and currently heads the work of UG Benevolentia, a Bosnian development NGO and holds an advisory position within the Youth Council of Bosnia and Herzegovina. Borislav is also a member of several other international organizations mostly working on projects in the fields of youth activism, democratization, civic development and conflict resolution. His academic and professional interests lie in the international legal and political principles of self-determination, the application of



development policies in the Western Balkans and contemporary political discourses on multiculturalism and migration in Europe.



Toni ČERKEZ is a master student of International Relations (1-year program) at CEU. Toni obtained his Bachelor at Lake Forest College (Lake Forest, IL) in 2017 in International Relations, Sociology and Anthropology. His senior thesis project was a critical constructivist approach to understanding EU-Turkey relations. Before that, he attended United World College in Mostar, graduating with an IB Bilingual Diploma (class of 2013). Currently, he is an intern with the Center for European Neighborhood Studies (CENS) at CEU. His research focus currently is critical theory, critical constructivism, EU

foreign policy and security (esp. enlargement and migration). His Master's thesis will cover the EU security and migration paradigm from a poststructuralist perspective.

Marko GODART PRELEC works on societies recovering from armed conflict or state failure. He is a specialist on Southern and Eastern Europe and an expert on the states of former Yugoslavia. Before joining SPP, Godart Prelec was executive director of the Balkans Group, a peacebuilding and statebuilding think tank based in Pristina, Kosovo. From 2008 to 2013 he was with International Crisis Group, directing its Balkans project, which focused on Bosnia and Herzegovina, Kosovo, Macedonia, and Serbia. He is the principal author of more than twenty reports and briefings, covering topics including constitutional reform, separatist threats, nationalism, post-conflict reconciliation, municipal government, regionalization, corruption and governance. He has also consulted for the UN Development Programme on conflict prevention and countering violent extremism. From 1999 to 2008 he worked on transitional justice, first as a research officer in the United Nations International Criminal Tribunal for the former Yugoslavia (ICTY) and then from 2005 as head of research at Bosnia's office for the



prosecution of war crimes. In the latter post, he wrote Bosnia's first comprehensive survey of war crimes, which serves as the basis for the country's prosecution strategy. At ICTY, he was lead researcher in the trial of Slobodan Milošević and worked on several trials and appeals involving Croat perpetrators. He studied history at Harvard College and received a Ph.D. in modern European history from Yale University in 1997 with a dissertation focused on extremist nationalism. From 1997 to 1999, he taught as an adjunct professor at several colleges and universities in the northeastern United States, including the United States Naval Academy in Annapolis, Maryland.

Hana SEMANIĆ is a research fellow at the Central European University, Centre for European Neighborhood Studies (CENS). She joined CENS in November 2010, concentrating on SEE-EU relations with a special focus on the Western Balkans. Hana earned her M.A. degree in International Relations and European Studies from the CEU in 2010. Her thesis focused on the security sector reform analyzing the dissimilar forms and modalities of local ownership in defense and police reforms in Bosnia and Herzegovina. Before coming to the CEU, she worked for a development agency (2007-2009) managing cross-border cooperation projects between Bosnia and Herzegovina and Croatia.
