



The vision for the EU's future energy security: What are the options?

Energy transformation is creating systemic shifts inside the EU and globally. To face the challenges, the European Union has established the Energy Union and made a considerable progress in achieving certain of its objectives. Regional cooperation was strengthened in the realm of decarbonisation, resilient infrastructure - interconnectors, LNG terminals etc, but the challenges are manifold. The energy geopolitics remains grounded on the fragmented energy order and the diversification of gas supplies is still a key issue where not only market-based calculations but also geopolitical rationale is at play.

This conferences aims to discuss the options to secure the needs of the EU in the energy realm - domestically and also within its Eastern neighbourhood where continuity of energy supplies is one of the pillars of the EU's policies. The first panel of the conference will focus on the perspectives and challenges facing the Energy Union. The second panel will strive to discuss the security implications of different gas transportation routes within the Baltic Sea and Black Sea-Caspian region (Nord Stream 2, Southern gas corridor, Turkish Stream etc).
